**APPELLEE’S AMENDED UNOPPOSED MOTION TO RESCHEDULE ORAL
ARGUMENT CURRENTLY SCHEDULED FOR FEBRUARY 9, 2022**

Pursuant to U.S. Vet. App. Rule 27, Appellee, Denis McDonough, Secretary of Veterans Affairs, respectfully moves this Court to reschedule oral argument, which is currently scheduled for February 9, 2022.

As grounds for this motion, the undersigned informs the Court that Sarah W. Fusina, Deputy Chief Counsel and Second Chair on this matter, will be unavailable on the currently scheduled date due to previously scheduled international travel. The undersigned counsel and Ms. Fusina have been the primary representatives for the Secretary in this case. Given the longevity of the matter and complexity of the issues in this case, the Secretary believes the Court will be better served by hearing from Counsel familiar with the matter.

The undersigned contacted Counsel for Appellant, Gideon J. Miller, and he has consented to both the filing of this motion and the rescheduling of the oral argument for the reasons announced above. To aid the Court in selecting a new
