

INTRODUCTION

You have requested VA provide a higher-level review of the issue(s) addressed in this decision.

Our records reflect that you are a Veteran of the Vietnam Era. You served in the Army from July 11, 1966 to July 12, 1968. We received your request for a Higher Level Review on August 22, 2023. Based on a review of the evidence listed below, we have made the following decision(s) on your claim.

- 2. Entitlement to an earlier effective date for the grant of eligibility for Dependents' Educational Assistance under 38 USC chapter 35 is granted, with a new effective date of November 25, 2009.



REASONS FOR DECISION

1. Entitlement to an earlier effective date for the grant of individual unemployability.

As a general rule, the effective date of an evaluation and award of pension, compensation or dependency and indemnity compensation based on an original claim, a claim reopened after final disallowance, or a claim for increase will be the date of receipt of the claim or the date entitlement arose, whichever is the later. (38 CFR 3.400, 38 CFR 3.155)

Total disability ratings for compensation based on individual unemployability may be assigned where the schedular rating is less than total if it is found that the disabled person is unable to secure or follow a substantially gainful occupation as a result of 1) a single service-connected disability ratable at 60 percent or more, or 2) as a result of two or more disabilities, provided at least one disability is ratable at 40 percent or more, and there is sufficient additional service-connected disability to bring the combined rating to 70 percent or more. For the purposes of one 60 percent disability, or one 40 percent disability in combination, the following will be considered as one disability: disabilities of one or both upper extremities; or of one or both lower extremities, including the bilateral factor, if applicable; disabilities resulting from common etiology or a single accident; disabilities affecting a single body system (e.g. orthopedic, digestive, respiratory, cardiovascular-renal, neuropsychiatric); multiple injuries incurred in action; or multiple disabilities incurred as a prisoner of war. Prior employment or unemployment status is immaterial if your disabilities render you unemployable. (38 CFR 3.340, 38 CFR 3.341, 38 CFR 3.343, 38 CFR 4.16)

The Board of Veterans' Appeals (BVA), in their decision of April 1, 2022, determined that you were unemployable from April 7, 2020 due to your service-connected skin conditions and your posttraumatic stress disorder. With the granting of a 60 percent evaluation for your service-connected skin conditions from August 28, 2002, in our decision of August 15, 2023, you met the schedular requirements for individual unemployability from August 28, 2002. Therefore, we have considered entitlement to an earlier effective date for individual unemployability within the scope of your claim for a higher evaluation for your service-connected skin conditions.

VA skin diseases examination, dated September 28, 2012, indicates that your skin conditions do not impact your ability to work.

VA skin diseases examination, dated July 11, 2016, indicates that your skin conditions do not impact your ability to work.

VA skin diseases contract examination, dated April 13, 2021, indicates that your skin conditions do not impact your ability to work.

conditions do not impact your ability to work.

VA skin diseases contract examination, dated December 30, 2021, indicates that your skin conditions do not impact your ability to work.

VA skin diseases contract examination, dated April 12, 2023, indicates that your skin conditions do impact your ability to work because of itchy skin affecting concentration on activities tasks.

We previously determined that you met the criteria for a 70 percent evaluation for your posttraumatic stress disorder from November 25, 2009 based on having occupational and social impairment, with deficiencies in most areas, such as work, school, family relations, judgment, thinking, or mood.

On VA Form 21-8940 received April 7, 2021, you reported that you last worked on February 26, 1978. You identified your posttraumatic stress disorder and your skin conditions as being the service-connected disabilities which prevented you from securing or following any substantially gainful occupation. The Board of Veterans' Appeals reached this same conclusion. The evidence does not demonstrate that you were unemployable due solely to your service-connected skin conditions. Rather, you were found to be unemployable due to combined effects of your your service-connected skin conditions and your posttraumatic stress disorder. We cannot therefore grant entitlement to individual unemployability prior to the date in which service connection was granted for posttraumatic stress disorder. We granted service connection for posttraumatic stress disorder from November 25, 2009, at 70 percent. Since you last worked in 1978, and your service-connected skin disabilities and your service-connected posttraumatic stress disorder are shown to have precluded you from securing or following any substantially gainful occupation, we have granted you entitlement to an earlier effective date for the granting of entitlement to individual unemployability.


Entitlement to an earlier effective date for the grant of individual unemployability is granted because with the assignment of a higher evaluation of 60 percent for your service-connected skin conditions from an earlier date, and with consideration of the combined effects of your service-connected skin conditions and your posttraumatic stress disorder, we have determined that an earlier effective date of November 25, 2009 is warranted for individual unemployability, the date in which service connection was granted for posttraumatic stress disorder, the disability that when combined with the effects of your service-connected skin conditions, renders you unemployable. (38 CFR 3.400, 38 CFR 4.16)

2. Entitlement to an earlier effective date for the grant of eligibility to Dependents' Educational Assistance under 38 U.S.C. chapter 35.

As a general rule, the effective date of an evaluation and award of pension, compensation or dependency and indemnity compensation based on an original claim, a claim reopened after final disallowance, or a claim for increase will be the date of receipt of the claim or the date entitlement arose, whichever is the later. (38 CFR 3.400, 38 CFR 3.155)

In a separate issue, we granted an earlier effective date of November 25, 2009 for the granting of a total evaluation based on individual unemployability. Evidence from that date sufficiently establishes permanency of your total evaluation.

Entitlement to an earlier effective date for the grant of eligibility to Dependents' Educational Assistance under 38 U.S.C. chapter 35 is granted because an earlier effective date of November 25, 2009 has been assigned for the granting of a total evaluation based on individual unemployability, and permanency of your total evaluation is sufficiently shown from that date. (38 CFR 3.400)

3. Evaluation of onychomycosis with dyshidrotic eczema, acne vulgaris, epidermal cysts, carbuncles and tinea pedis, currently evaluated as 60 percent disabling.

The rating schedule is primarily a guide in the evaluation of disability resulting from all types of diseases and injuries encountered as a result of or incident to military service. An increase in the evaluation assigned for a disability is warranted when the average impairment in earning capacity resulting from such diseases and injuries in civil occupations has increased and the disability picture meets the criteria required for a higher rating. (38 CFR 3.321, 38 CFR 4.1, 38 CFR 4.7)

Our decision of August 15, 2023 assigned a 60 percent evaluation for your service-connected skin conditions from August 28, 2002 under the old rating schedule criteria.

VA skin diseases contract examination, dated April 12, 2023, shows you take Clobetasol, a topical corticosteroid or other immunosuppressive medication, on a constant/near-constant basis for treatment for your skin conditions. Your skin conditions affect at least 5 percent but less than 20 percent for total body area and exposed areas. Your skin conditions do not cause scarring.

The findings of the most recent VA contract examination would only support a 10 percent evaluation. However, since we assigned a 60 percent evaluation for your skin conditions from August 28, 2002, that evaluation became protected on August 28, 2022. Therefore, the evaluation cannot be reduced unless there is a showing of fraud, and not such finding of fraud it shown in your case. (38 CFR 3.951, 38 CFR 4.1118)

The evaluation of onychomycosis with dyshidrotic eczema, acne vulgaris, epidermal cysts, carbuncles and tinea pedis, is continued as 60 percent disabling.

We have assigned a 60 percent evaluation for your onychomycosis with dyshidrotic eczema and acne vulgaris based on:

• More than 40 percent of the exposed areas affected

Additional symptom(s) include:

- Less than 5 percent of the entire body affected
- No more than topical therapy required during the past 12-month period

Higher evaluations may also be warranted based on:

- Disfigurement of the head, face, or neck
- Scars considered disabling due to limitation of function of the affected part; or,
- Painful or unstable scar(s) (38 CFR 4.118)

This is the highest schedular evaluation allowed under the law for dermatitis. (Historical 38 CFR 4.118 effective prior to August 13, 2018)

To establish entitlement to an extra-schedular evaluation for your onychomycosis with dyshidrotic eczema, acne vulgaris, epidermal cysts, carbuncles and tinea pedis, evidence must indicate your disability presents such an exceptional or unusual disability picture with such related factors as marked interference with employment or frequent period of hospitalization to render impractical the application of the regular rating schedule standards. After a review of the evidence of record, there is no indication that your disability presents such an exception or unusual disability picture as to render impractical the application of the regular rating schedule standards. As such, your case was not referred to the Director of Compensation Service for consideration of an extra-schedular evaluation. (38 CFR 3.321)
