SECRETARY'S RESPONSE TO COURT ORDER DATED NOVEMBER 25, 2014

In January 2014, Petitioner, Gene S. Groves, filed a petition for extraordinary relief in the form of a writ of mandamus (Petition). In a November 25, 2014, Order the Court, *inter alia*, held the Secretary in civil contempt with regard to the petition and ordered the Secretary to pay sanctions in the form of reasonable expenses associated with the litigation of the petition. *See* November 25, 2014, Court Order.

On December 9, 2014, Petitioner filed a "Motion for Award of Expenses" (Motion) with the Court. In that motion, Petitioner asserts that he is entitled to an award of fees associated with the litigation of the underlying petition in the amount of \$1,325.00. See Petitioner's Motion.

In response, the Secretary is not contesting the reasonableness of the Petitioner's fees. Petitioner's application satisfies the jurisdictional requirements under the Equal Access to Justice Act (EAJA), 28 U.S.C. § 2412(d). See March v. Brown, 7 Vet.App. 163 (1994) (holding that pro se petitioner's may receive reimbursement for certain expenses under EAJA).

WHEREFORE, the Secretary respectfully responds to the Court's November 25, 2014, Order and advises the Court that he does not contest Petitioner's application for an award of fees and expenses in an amount deemed reasonable by the Court, up to \$1,325.00.
