**APPELLEE’S MOTION FOR AN EXTENSION OF TIME
TO RESPOND TO APPELLANT’S BRIEF
UNTIL NOVEMBER 7, 2019**

Pursuant to U.S. Vet. App. R. 26(b), Appellee, Robert L. Wilkie, Secretary of Veterans Affairs, respectfully moves the Court for a 45-day extension of time within which to respond to Appellant’s Brief. If not for this motion, the Secretary’s brief would be due on September 23, 2019.
