**APPELLEE’S MOTION FOR AN EXTENSION OF TIME TO RESPOND TO
APPELLANT’S BRIEF UNTIL DECEMBER 5, 2019**

Pursuant to U.S. Vet.App. R. 26(b), and 27(a), Appellee, Robert L. Wilkie, Secretary of Veterans Affairs, respectfully moves the Court for a 45-day extension of time within which to respond to Appellant’s Brief. If not for this motion, the Secretary’s Brief would be due on October 21, 2019.

Good cause exists for this motion for an extension of time.
