**APPELLEE'S MOTION FOR A 45-DAY
EXTENSION OF TIME, UNTIL FEBRUARY 28, 2020**

Pursuant to U.S. Vet. App. R. 26(b), the Secretary respectfully requests a 45-day extension of time within which to respond to Appellant's brief. If not for this motion, the Secretary's brief would be due on January 14, 2020.
