APPELLANT'S SUPPLEMENTAL APPLICATION FOR AN AWARD OF ATTORNEY FEES, COSTS AND OTHER EXPENSES UNDER THE EQUAL ACCESS TO JUSTICE ACT

Pursuant to U.S. Vet.App. R. 39 and 28 U.S.C.A. § 2412 (West 2014), Appellant Shawn P. Lacey, by and through his counsel, Jennifer A. Zajac and Linda E. Blauhut, hereby submits his supplemental application for an award of attorney fees, costs, and other expenses ("EAJA") in the amount of \$3,307.92. This submission is timely, as it is within 20 days after the Court's August 18, 2020, panel decision, granting Mr. Lacey's initial application for EAJA fees. U.S. VET.App. R. 39(b).

The Supreme Court has held that a prevailing party is entitled to supplemental fees for the time taken to litigate a disputed fee application, without needing to establish that the Government's position in the fee dispute itself was

unjustified. *Comm'r, I.N.S. v Jean*, 496 U.S. 154, 160-61 (1990); *see Wagner v. Shinseki*, 640 F.3d 1255, 1259-60 (Fed. Cir. 2011); *McNeely v. West*, 12 Vet.App. 162, 164 (1999). Instead, the "sole consideration in determining a fees-for-fees supplemental application is one of reasonableness." *McNeely*, 12 Vet.App. at 164.

To aid the Court in this determination, a statement from counsel for Appellant is attached. It itemizes services rendered in the fee litigation, the time expended, and the rate at which fees were computed. The time expended for litigating the EAJA fee is 15.25 hours. The hourly rate for Ms. Zajac is \$218.12 and the hourly rate for Ms. Blauhut is \$209.56. The total amount claimed is \$3,307.92.

WHEREFORE, based on the foregoing, Appellant respectfully requests that the U.S. Court of Appeals for Veterans Claims award supplemental attorney fees in the amount of \$3,307.92, *jointly to Appellant and Paralyzed Veterans of America*.

I, Jennifer A. Zajac, make the following declaration in support of Appellant Shawn P. Lacey's supplemental application for an award of attorney fees, costs, and other expenses, in connection with the above-captioned appeal.

- 1. I was the lead attorney of record for Appellant in the proceedings before the U.S. Court of Appeals for Veterans Claims.
- 2. Linda E. Blauhut, Deputy General Counsel, provided supervisory review.
- 3. I have reviewed the combined billing statement and am satisfied that it accurately reflects the work performed by all representatives.

- 5. Under 28 U.S.C.A. § 2412(d)(1)(D)(2), the applicable rate is \$125.00 per hour for appeals filed after March 29, 1996. Mr. Lacey filed his appeal with the Court in September 2017. An attorney may seek a rate in excess of \$125.00 per hour based on the increase in the cost of living since the EAJA was amended in March 1996. *See* 28 U.S.C.A. § 2412(d)(2)(A)(ii); *Mannino v. West*, 12 Vet.App. 242 (1999).
- 6. For Ms. Zajac: The \$125.00 attorney rate, adjusted for inflation for the West Region, was \$218.12 in April 2020, the month undersigned counsel researched and filed Appellant's Reply to the Secretary's Response. *See* Bureau of Labor Statistics Data, CPI-U, at http://www.bls.gov/cpi/home.htm (last visited August 24, 2020); *Elcyzyn v. Brown*, 7 Vet.App. 170, 181 (1994) (suggesting the date Appellant's Brief is filed as an appropriate "mid-point"). This rate was calculated by creating a ratio using the CPI-U for the West Region between March 1996 (\$156.4) and April 2020 (\$272.913), for the rate of \$100, and then applying that ratio for calculating the change for \$125. *See id*. The "billable fees" amount was calculated, then, by multiplying the \$218.12 rate by the total number of hours Ms. Zajac spent working on the Reply (13.1), to equal \$2,857.37.
- 7. For Ms. Blauhut: The \$125.00 attorney rate, adjusted for inflation for the Washington Region, was \$206.57 in April 2020, the month co-counsel provided supervisory review. *See* Bureau of Labor Statistics Data, CPI-U, at

http://www.bls.gov/cpi/home.htm (last visited August 24, 2020); see Elcyzyn, 7

Vet.App. at 181. This rate was calculated by first calculating what the CPI-U rate

was for the Washington Region for April 2020. To do that, an average was taken

for March 2020 (\$265.385) and May 2020 (\$265.733), to equal \$265.559. This

number was then used to create a ratio for the CPI-U for the Washington Region

between March 1996 (\$158.4) and April 2020 (\$265.559), for the rate of \$100, and

then applying that ratio for calculating the change for \$125. See id. The "billable

fees" amount was calculated, then, by multiplying the \$209.56 rate by the total

number of hours spent working on the Reply (2.15), to equal \$450.55.

8. The two "billable fees" amounts were then added together to obtain

the "total hourly billable fees" amount of \$3,307.92.

9. The "TOTAL SUPPLEMENTAL AMOUNT REQUESTED" is

\$3,307.92.
