APPELLEE'S SOLZE NOTICE TO THE COURT

Pursuant to this Court's holding in *Solze v. Shinseki*, 26 Vet.App. 299, 301 (2013), that, "in all cases before this Court, the parties are under a duty to notify the Court of developments that could deprive the Court of jurisdiction or otherwise affect its decision," the Secretary of Veterans Affairs, Denis McDonough, files this notice in accordance with such directive.

The April 22, 2022, Board of Veterans' Appeals (Board) decision on appeal concerns the claims of entitlement to service connection for (i) ovarian cancer or pre cancerous cells, (ii) a miscarriage, (iii) fallopian tube endometriosis, and (iv) a uterine cyst. Further, Appellant's argument in her initial brief, in part, references her claims of entitlement to service connection for left bicep tendinitis, a left rotator cuff disability, a right hammer toe disability, and vocal cord polyps. *See* Appellant's Brief at 13-17. As outlined in Appellee's brief submitted to the Court on February 2, 2023, the record before the agency (RBA) contains a relevant November 2021 supplemental claim of entitlement to service connection for a uterine cyst, fallopian

tube endometriosis, miscarriage, ovarian cancer or precancerous cells, left bicep tendinitis and left rotator cuff disability, vocal cord polyps, and right hammer toe disability, as well as rating decisions and a notice of disagreement (NOD) regarding such claims.

On that same day, the Secretary also informed that additional, relevant documents were created and submitted after the April 22, 2022, Board decision on appeal and, therefore, are not included in the RBA. Particularly, the Veterans Benefits Management System (VBMS) showed that in May 2022, Appellant submitted a NOD that appealed to the Board the Department of Veterans Affairs Regional Office's March 2022 denial of entitlement to service connection for gynecological conditions and vocal cord polyps and selected the Board hearing option. See February 2, 2023, Solze Notice Exhibit A. It also showed that in August 2022 and in response to the March 2022 rating decision, Appellant submitted a supplemental claim of entitlement to service connection for left shoulder conditions and right foot hammer toe, February 2, 2023, Solze Exhibit B, and Appellant's supplemental claim was adjudicated in a November 2022 rating decision, February 2, 2023, Solze Exhibit C.

Since that time, VBMS shows more relevant documents that have been created after the April 22, 2022, Board decision. Specifically, it shows that the Board sent Appellant and her counsel a letter in May 2022 informing that it had received her Board Appeal request (VA Form 10182) and that her appeal has been

placed on the Hearing docket¹. Exhibit A. It also shows that Appellant submitted a Decision Review Request: Board Appeal (VA Form 10182) to the Board in January 2023 regarding the issues of entitlement to service connection for left shoulder conditions and right foot hammer toe as adjudicated in the November 2022 rating decision. Exhibit B; see also February 2, 2023, Solze Exhibt C (November 2022 rating decision). Finally, VBMS reflects that the Board sent Appellant and her counsel a letter in February 2023 informing that it had received her Board Appeal request (VA Form 10182) and that her appeal has been placed on the Hearing docket². Exhibit C.

The Secretary submits these documents, consistent with the Court's holding in *Solze*, as they provide important context to the procedural history of Appellant's November 2021 supplemental claim and to issues in this appeal pertaining to due process and prejudice, which may "otherwise affect [the Court's] decision." *Solze*, 26 Vet.App. at 301.

WHEREFORE, the Secretary respectfully notifies the Court of the above, relevant developments in this case.

The Board of Veterans' Appeals received your Board Appeal request (VA Form 10182). Based on the Board appeal option you selected on the form, your appeal has been placed on the Hearing docket.

What happens next?

You will receive a letter from the Board when your hearing is scheduled. While not required, you have the option to submit new evidence during your hearing or within 90 days after the date of your hearing. Any evidence submitted after the date of the decision you are appealing but prior to the date of your hearing cannot be considered by the Veterans Law Judge. You can start preparing evidence now, but you can only submit it during your hearing or within 90 days after the date of your hearing. If you do not appear for your scheduled hearing, and the hearing is not rescheduled, you may submit evidence within 90 days following the date of the scheduled hearing.

You may also choose to withdraw your hearing request. If you choose to withdraw your hearing request, you can only submit evidence within 90 days following the Board's receipt of your hearing withdrawal.

What if I want to change my Board appeal request by switching AMA dockets?

You may request to change from one Board AMA docket to another by submitting a new VA Form 10182 with the new docket choice and a list of issues you want considered under the new docket. You can only switch from one AMA docket to another if you have not had a hearing or submitted evidence following the Board's receipt of your original VA Form 10182.

Typically, requests to change AMA dockets must be filed at the Board within 60 days of the date the Board received the VA Form 10182 that you have already submitted, or within one year of the VA decision being appealed, whichever date is later. However, **you may submit a good cause extension request**. To request an extension of time to submit a VA Form 10182 docket switch request, please note the reasons why you believe there is good cause on or with your VA Form 10182 docket switch request.

What if I would like my case advanced on the Board's docket?

If you are suffering from a serious illness, or you are under severe financial hardship, or have other sufficient cause, you can request to have your appeal "Advanced on the Docket," or moved to the front of the line. If you are age 75 or older, your appeal will automatically be prioritized, and you do not have to submit anything further.

If applicable, you may submit a brief explanation of the reasons why the Board should prioritize your case. You must include documentation that supports your explanation. For example, if you have:

- **Severe financial hardship**: Examples of evidence you may submit to demonstrate severe financial hardship include, but are not limited to, evidence of homelessness, a bankruptcy petition, or a home foreclosure or eviction notice.
- **Serious illness**: Examples of evidence you may submit to demonstrate serious illness include, but are not limited to, a physician's statement documenting terminal or serious illness, preferably with clinical findings.

What if I want to change my representation?

You have 90 days from the date the Board receives your Board Appeal request (VA Form 10182) or until the Board issues a decision (whichever comes first) to change your representative.
